1. Identification of the Substance/Preparation and of the Company

Product Name: Talc Powder ETO Treated

Grade: IP/BP/USP

Chemical Name: Hydrated Magnesium Silicate

Product Use: Pharmaceutical excipient, cosmetic ingredient, personal care, industrial applications.

2. Hazards Identification

- Not classified as hazardous according to GHS standards.
- May cause mechanical irritation to eyes.
- Inhalation of high concentrations may cause respiratory discomfort.

4. First Aid Measures

Inhalation:
